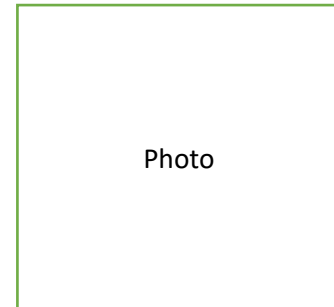

Issuance Policy

1	Access to the TPQ beaches are only exclusive to residents of The Pearl-Qatar (Owners and Tenants). Employees of any company operating within The Pearl-Qatar are excluded from this privilege.
2	The TPQ Registry management reserves the right to reject any application that is deemed un-eligible.
3	Upon leasing his/her property, the owner automatically waives his/her access rights in favor of the tenant. Full access to amenities will be granted to the new resident (parking spaces, beach access, etc)
4	However, for cases where the parties agree that the owner/s wishes to retain one of his parking space/s (for properties with more than one parking space), TCAD rightfully issues car pass for both parties, provided that this agreement is declared within the tenancy contract.
5	Photos are mandatory with the application. All applicants must provide clear and latest 2x2 photo per person.
6	TPQ Beach Pass is issued per one verified individual starting from 16 years old and is only issued based on the maximum allowable occupants of a unit
7	For residents that will terminate or will not be renewing their lease contract, the passes issued must be returned to the TPQ Registry. Should in case the pass had been lost, TPQ Registry must be informed by either the resident or the building management in writing (please send the email to registry.reception@udcqatar.com, please use the unit address as subject)
8	New pass applications must have the old resident pass attached within the application. If card was lost, the email sent to the TPQ Registry that declared the loss of the pass will substantiate the application. Otherwise, failure to provide the above will result in immediate rejection.
9	Unsigned SPAs are subjected to verification
10	Unsigned and/or unstamped lease agreements are subject to immediate rejection
11	Immediate approval/issuance will be provided to government registered leases
12	UDC is committed to adhere and preserve the Qatari morals and customs hence, additional official documents might be requested for verification purposes.
13	Issuances of the TPQ Temporary Access Pass are within 72 hours from the time of submission

Important Reminders

1	Ensure that your Temporary Beach pass is still valid to avoid any inconvenience when accessing TPQ Facilities. Apply for pass renewal once your lease agreement is renewed, otherwise, pass will be confiscated and access to facilities will be restricted.
2	Temporary Access Pass is for use of card holder only and not to be given to any other person. Pass will be confiscated upon breach of this rule.
3	You may take 2 guest for every Beach pass.
